### REMEMBERING: The 4<sup>th</sup> of July



Today is June 28, 2020 and the 4<sup>th</sup> of July is approaching, although based on the continual noise every evening you'd think that the 4<sup>th</sup> of July has been going on for over a month. Since when did it become the thing to do to set off fireworks at the start of June? Growing up in the 60's Dad used to complain if he heard fireworks on July 3<sup>rd</sup>. Of course, back then we didn't buy the stuff they do today. We usually got one package of fireworks, which

typically had (1) 2 or 3 cones, (2) a box of black snakes (3) maybe a pinwheel or two and, of course (4) sparklers. Some rebellious teens would get black cat firecrackers and pop bottle rockets. We could hardly wait until it got dark enough to set the fireworks off. Somehow the expectations and reality didn't quite line up. The cones emitted sparks for about 30 seconds and the



rest of the stuff was quite tame. All-in-all it was over in



less than 45 minutes and that was spacing the lighting out. For many, the 4<sup>th</sup> meant going to Del Mar Park to see the city display bringing picnic supplies and a blanket. My Dad hated crowds so I can only recall a time or two of going there, however, now

that I'm all grown up, we almost always go see some elaborate display be it from a city or at the Rockies games.

Time waits for no man and our history eventually becomes shared memories of people and places. Preservation can help keep those memories a little more tangible so that we can share with future generations.

Spotlight on the Mayors of Aurora

Did you know that the Town of Fletcher/City of Aurora have had 43 Mayors since its beginnings back in 1891? With each issue of the Advocate Newsletter we'll take a quick look at each of them. Special thanks to Carolyn Brassell for her research and assistance.

> MAYOR #22 Fred Harrison

- Served from 1926 1927
- He was born 17 May 1881 in Kansas
- Married June Wilkerson on 11 May 1912 in Littleton, Colorado
- They had 2 daughters, Alice and Merle
- He was a lawyer in Aurora and in 1929 and later became an Assistant Attorney General
- He was a Captain in the Army and part of the Boxer relief expedition to Peking, China
- He retired from the Army in November 1922
- He had a house at 1624 Dallas Street in 1930
- He was active in the Order of Eastern Star and American Legion
- He formed a law partnership with his brother which was dissolved in 1936
- He would have been 45 years old when he became Mayor
- He left for California around 1941
- He died 24 July 1946 at the age of 73 in Los Angeles, California
- Colorado Governors at the time he was Mayor were Clarence Morley & Billy Adams
- While he was in office:
  - The original church of St. Therese parish was established at 14<sup>th</sup> & Dallas
  - Aurora's first park was dedicated at 16<sup>th</sup> and Dayton
  - The first sewage plant was built
  - Fitzsimons Army post has its own radio station KEUP



**Juanita Preston Sparks** was a long-time member of the Aurora Historical Society. She was born May 30, 1920 and died June 12, 2020. She had just celebrated her 100<sup>th</sup> birthday.



Juanita served as the treasurer of the Aurora Historical Society from 1981-1983, and as a director on the board in 1998. She also served as the newsletter editor for many years. She was a retired Aurora Public School teacher. Mother of David P. Sparks and grandmother of Luayne & Kendra; great grandmother of 6, great-great grandmother of 3.

#### In Memory

Services were conducted on May 27, 1995 for Helen S. Preston, 96, an Aurora resident for 70 years and leader of the community as it grew from a small suburban town toward its ranking of the state's third largest city.

Preston devoted much of her life to volunteer work. She was one of the founding members of the Tri-County Health Department and served on its board of directors for 25 years.

During the Depression she and others started a hotlunch program in Aurora schools. The food was cooked in her kitchen and transported by wagon to the students.

She worked to establish well-baby clinics in Aurora and was a prime mover in getting tuberculosis screening established in elementary schools.

She was the historical consultant for the 1978 book *Early Aurora* by C. Vincent and Leona McFadden and was one of the first members of the Aurora Historical Commission, which established the Aurora History Museum. She was accorded the honor of cutting the ribbon in 1991 when the museum opened in a new site adjoining the Municipal Justice Center, at 15001 E. Alameda Dr.

She also had leadership roles in the Rebekah Lodge, the VFW Post 3631, Ladies Auxiliary, the Women's Club of Aurora, and other civic and service organizations. She was the first elected president of the Aurora Parent Teacher Association. Her husband, Homer Preston, who died in 1959, was elected an Adams County Court Judge in 1932 and served as the county's juvenile court judge. He had served overseas in World War I and was assigned to Fitzsimons Army Medical Center in its early years.

She was born March 12, 1899, in Gibson City, Ill., and was a rural schoolteacher before she married. She and her husband lived in a home on Fulton Street for 35 years.

Survivors include her children, Juanita Sparks, Hertel "Pete" Preston and Horatio Preston, seven grandchildren, and nine great-great grandchildren.

### **<u>100 Years Ago - Volume 11 Number</u>** 39 July 2, 1920

The meeting of the fire department, Monday evening, was a most interesting one, as Fire Chief Healey, of Denver, gave us a splendid and a most instructive talk on fire fighting.

It was to be regretted that so few turned out to hear it. At least every man in this town should take an active interest in the fire department if it is to be worthy of being called one. We have all been taught or should have been taught, the crying need of a properly trained and equipped one. However willing you may be to help on the day that an actual fire occurs, unless you are trained, you would be more in the way than anything else. We are not begging you for anything-it is your own interests and your own homes that you are protecting. Your money will help some, but your presence and active interest will help a great deal more.

Fire Chief Healey explained the methods of fighting various kinds of fires and the inestimable value of a trained and properly equipped department. He strongly advised us to consult with the board of fire underwriters before investing a cent and to be guided entirely by their wishes, as, of course, it rests entirely with them what our fire rate shall be. He promised us assistance at any time; that he would be glad at any time to help us anyway he could, and he invited the men of the department to be present at drills of the Denver fire department. In fact the Chief, considered one of the best fire fighters in the country, proved to be a regular guy, and Aurora thanks him.

At the next meeting of the department let every man in Aurora answer present.

## 75 Years Ago

CAUGHT 7-POUND TROUT

Clinton Strait caught a 7-pound Mackinaw trout 29 inches long July 3. Mr. and Mrs. Strait and daughter, Gail, accompanied by\_a neighbor, Mrs. Weisenberger, were enjoying a vacation in the mountains, and after riding 12 miles on horseback arrived at beautiful Crescent Lake, where snow still abounds. It was here that Mr. Strait landed the 7-pound trout, on a fly rod. He says that after 15 years fishing he really landed a BIG fish-29 inches long! and it was quite a thrill. He had previously caught fish weighing 4 or 4 1-2 pounds, but that landing this whopper came as a complete surprise.

On July 4th the party attended the rodeo at Steamboat Springs.

They report a grand trip, and lots of beautiful scenery.
